A COUNCIL BILL

TO APPROVE the application to the United States Department of Interior for the FY25 Tribal Wildlife Grant (FOA: F25AS00265).

WHEREAS, the Choctaw Nation (the "Nation") recognizes the value of protecting wildlife, habitats and species through the restoration of native grassland at the Talawanda Lakes and Ti Valley properties;

WHEREAS, the maximum federal budget is \$200,000.00 with no required tribal match; and

WHEREAS, funds for Tribal Wildlife Grant meet the Nation's strategic goals of protecting and promoting Choctaw culture and exercising sovereignty as well as strengthening financial growth by improving land value.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to apply to the United States Department of States Department of Interior for the FY25 Tribal Wildlife Grant (FOA: F25AS00265) for a maximum federal award of \$200,000.00 (Two Hundred Thousand Dollars and 00/100) with no tribal match.

BE IT FURTHER ENACTED by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
