



PUBLIC NOTICE of Official General Election Results 2025 and Special Election Run-off Information for District 5

To the Tribal Members of The Choctaw Nation of Oklahoma

In accordance with the Chief and Tribal Council Election Ordinance, adopted by CB -123-22 (amended by CB -24-25).

Notice is hereby given that the contest period for Irregularities or Fraud (Article XIX) and Recount (Article XX) closed at 4:30 p.m. on July 16, 2025. No contests or recounts were filed. Accordingly, the Election Board has formally concluded the General Election cycle with the certification and signing of the final General and Special Election Results, which will be submitted to the Bureau of Indian Affairs. The duly certified results are listed below:

Tribal Council District 4 Winner: Jess Henry with 651 votes (73.73%).

Tribal Council District 12 Winner: Regina Mabray with 587 votes (76.13%).

11,122 votes in the affirmative were required to pass the amendments to the Constitution of the Choctaw Nation.

Legislative Proposition Number 2025 001: Did not pass with 9,317 in the affirmative.

Legislative Proposition Number 2025 002: Did not pass with 8,578 in the affirmative.

Legislative Proposition Number 2025 003: Did not pass with 9,076 in the affirmative.

Special Election – Tribal Council District 5: No candidate received more than 50% of total votes cast and Article XXII, Section 3 requires a Run-off Election to occur. The two candidates that received the most votes will appear on the run-off ballot:

Earl Smith with 201 votes (20.08%); and,

Jennifer Turner with 343 votes (34.27%).

- **Run-off Election Day:** August 9, 2025, 7:00 a.m. – 7:00 p.m.
