**JAMES DRY INTRODUCED THE FOLLOWING COUNCIL RESOLUTION**

**A COUNCIL BILL**

**TO AUTHORIZE** the drawdown of an investment bonds account held by the United States and for the benefit of the Nation.

**WHEREAS**, the Choctaw Nation of Oklahoma (“the Nation”) has authorized to sell security investments, CUSIP investment bonds held by the United States and for the benefit of the Nation, in accounts PL7150706 and PL7543704, prior to the maturity date of the security investment; and

**WHEREAS**, the Trust Reform Act and 25 C.F.R. § 115.813 require the Nation to state that the security be sold; and

**WHEREAS**, the Nation acknowledges that it may incur a penalty when the security is sold; and

**WHEREAS**, the Nation acknowledges that the security may lose value if it is sold prior to maturity.

**WHEREAS**, following the sale of the security, the Nation wishes to drawdown the cash available from the Choctaw Nation PL7150706 and PL7543704 accounts.


**NOW, THEREFORE BE IT RESOLVED**, that the Choctaw Tribal Council of the Choctaw Nation of Oklahoma hereby authorizes the drawdown of the accounts PL7150706 and PL7543704 that hold all funds related to the sale of the investment securities previously authorized by this Tribal Council for such sale, with said funds to be deposited within the Nation’s General Fund.
