WHEREAS, the Nation acquired 3915 South 9th Avenue in Durant in fee simple and had previously utilized the property as an equestrian center;

WHEREAS, the Nation has submitted to the United States government for the subject real property to be held in trust for the benefit of the Choctaw Nation of Oklahoma;

WHEREAS, the Nation has determined that, in connection with the pending trust application, all housing, fencing, and ancillary structures (the "Improvements") are to be demolished;

WHEREAS, the Nation has determined the current book value of the Improvements as of August 19, 2025, is Two Hundred Seventy-Four Thousand Four Hundred Forty-Four US Dollars and Forty-Eight Cents (\$274,444.48); and

WHEREAS, the Council has determined that it is in the best interests of the Nation to demolish the improvements located at 3915 South 9th Avenue in Durant, Oklahoma.

THEREFORE BE IT ENACTED by the Council that this Bill be cited as approval for the demolition of the Improvements located at 3915 South 9th Avenue, Durant, Oklahoma 74701.
