**JAMES DRY INTRODUCED THE FOLLOWING COUNCIL BILL**

**A COUNCIL BILL**

**TO APPROVE** Funding for the Addition of Gaming and Expansion of the Facility Located in Garvin, Oklahoma

**WHEREAS**, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Tribal Council of the Nation (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

**WHEREAS**, the Nation currently owns and operates a travel plaza in Garvin, Oklahoma (the "Facility");

**WHEREAS**, the Nation seeks to offer gaming ("Gaming") at the Facility under the Nation's Tribal Gaming Compact with the State of Oklahoma to promote the general welfare of its people and further the Nation's self-determination and economic independence;

**WHEREAS**, the Council has determined that it is in the best interests of the Nation to expand the Facility to offer Gaming;

**WHEREAS**, the Council has determined that it is in the best interests of the Nation to approve funding of up to Five Million One Hundred Nineteen Thousand Dollars (\$5,119,000) for improvements, upgrades and expansions to offer Gaming at the Facility (the "Project Costs");

**WHEREAS**, satisfactory due diligence, as reasonably determined by and on terms reasonably acceptable to the Chief of the Nation, shall be completed prior to the expansion and addition of Gaming at the Facility; and

**WHEREAS**, the Council has determined that the Project Costs shall be funded from unrestricted funds.

**THEREFORE BE IT ENACTED** by the Council that this Bill be cited as approval for the funding of the Project Costs.

**BE IT FURTHER ENACTED** by the Council that the expansion and addition of Gaming at the Facility shall be subject to the completion of satisfactory due diligence, as reasonably determined by and on terms reasonably acceptable to the Chief of the Nation.

**BE IT FURTHER ENACTED** by the Council that this Bill be cited as approval that the funding of the Project Costs shall come from unrestricted funds.
