

**TO APPROVE FUNDING FOR THE PURCHASE OF AN EQUITY INVESTMENT IN A
SPORTS, ENTERTAINMENT AND HOSPITALITY VENTURE**

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION

JAMES DRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE funding for the purchase of an equity investment in a sports, entertainment and hospitality venture.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Tribal Council of the Nation (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition and management of tribal investment;

WHEREAS, the Nation has the opportunity to make a strategic investment in a sports, entertainment and hospitality venture (the "Investment") to promote the general welfare of its people and take further advantage of opportunities for self-determination and economic independence;

WHEREAS, the Council has determined that it is in the best interests of the Nation to approve funding for up to Twenty Million Dollars (\$20,000,000), plus reasonable and customary due diligence and closing costs (collectively, the "Equity Investment Amount"), to be used for the purchase of an equity investment (the "Equity Investment") in one or more entities that will purchase the Investment;

WHEREAS, the Council has determined that closing on the Equity Investment shall be subject to the completion of satisfactory due diligence, as reasonably determined by the Chief of the Nation; and

WHEREAS, the Council has determined that it is in the best interests of the Nation to fund the Equity Investment Amount from unrestricted funds.

THEREFORE, BE IT ENACTED by the Council that this Bill be cited as approval for the funding of the Equity Investment Amount to purchase the Equity Investment, subject to the completion of satisfactory due diligence, as reasonably determined by the Chief of the Nation.

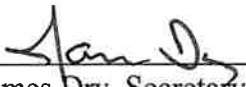
BE IT FURTHER ENACTED by the Council that this Bill be cited as approval that the funding for the Equity Investment Amount shall come from unrestricted funds.

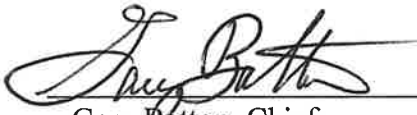

SPORTS, ENTERTAINMENT AND HOSPITALITY VENTURE**

Purpose/Need of Council Bill: The Nation has the opportunity to make a strategic investment in a sports, entertainment and hospitality business with over 200 golf courses, private clubs, sports facilities and destination resorts nationwide. A partnership with this company provides alignment for the Choctaw Nation's existing hotels & resorts, and potential future development of best-in-class sports and sports entertainment facilities and destinations. This Council Bill approves funding for the purchase of an equity investment in this business. Closing on this investment is subject to the satisfactory completion of due diligence as determined by the Chief of the Nation, in his reasonable discretion. This Council Bill supports the Nation's Tribal Strategy – Strengthen Financial Growth and Economic Sustainability and the Choctaw Nation's Strategic Objective: SO# 12.4.4 Strategic Acquisitions & Partnerships.

Title of Council Bill: To approve funding for the purchase of an equity investment in a sports, entertainment and hospitality venture.

Budget: Up to \$20,000,000, plus reasonable and customary due diligence and closing costs.
