

**TO APPROVE A SERVICE LINE AGREEMENT, IN FAVOR OF OKLAHOMA NATURAL GAS COMPANY, A DIVISION OF ONE GAS, INC., ON LAND HELD BY THE USA IN TRUST FOR THE CHOCTAW NATION OF OKLAHOMA IN BRYAN COUNTY, OKLAHOMA**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION**

**JAMES DRY INTRODUCED THE FOLLOWING BILL**

**A COUNCIL BILL**

**TO APPROVE** a service line agreement, in favor of Oklahoma Natural Gas Company, a Division of ONE Gas, Inc., on land held by the USA in Trust for the Choctaw Nation of Oklahoma in Bryan County, Oklahoma;

**WHEREAS**, in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation;

**WHEREAS**, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma, the Tribal Council (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

**WHEREAS**, Oklahoma Natural Gas Company, a Division of ONE Gas, Inc., has requested to install a new service gas line at the new Community Center, located in the NW¼ NW¼ of Section 7, Township 7 South, Range 9 East in Bryan County, OK. This is in the best interest of the Choctaw Nation because the service line will provide gas to the Community Center;

**WHEREAS**, the payment will be \$0.00;

**WHEREAS**, the service line shall be for a perpetual term, so long as it is used for its intended purpose; and

**WHEREAS**, the Council has determined it is in the best interest of the Nation to grant this service line agreement in favor of Oklahoma Natural Gas Company, a Division of ONE Gas, Inc.

**THEREFORE BE IT ENACTED** by the Council that this Bill be cited as approval of the Service Line Agreement, in favor of Oklahoma Natural Gas Company, a Division of ONE Gas, Inc., on land held by the USA in Trust for the Choctaw Nation of Oklahoma in Bryan County, Oklahoma.


**BE IT FURTHER ENACTED** by the Council that this Bill be cited as approval of the acceptance of the service line agreement for a payment of \$0.00 for a perpetual term, so long as the service line is used for its intended purpose of providing service to property owned by the Choctaw Nation of Oklahoma.

**BE IT FURTHER ENACTED** by the Council that this Bill be cited as an acknowledgment that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver, and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.


