**TO APPROVE THE CHOCTAW NATION OF OKLAHOMA'S
2026 OPIOID SETTLEMENT FUNDS PLAN**

IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION
JAMES DRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE and adopt the Choctaw Nation of Oklahoma's 2026 Opioid Settlement Funds Plan.

WHEREAS, the Choctaw Nation of Oklahoma (the “Nation”) has received and expects to continue to receive opioid settlement funds pursuant to national opioid litigation settlements;

WHEREAS, pursuant to the settlement agreements, the Nation’s opioid abatement amounts are to be used only for opioid remediation purposes as defined in those agreements;

WHEREAS, the Nation has prepared the 2026 Opioid Settlement Funds Plan, updated April 20, 2026, to guide the compliant and strategic use of such funds through direct tribal member assistance, expansion and continuation of health services, public health and safety initiatives, projects under consideration or future response, and feasibility-reviewed items; and

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma finds it is in the best interest of the Nation to approve and adopt the 2026 Opioid Settlement Funds Plan. See Exhibit A.


NOW THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Act be cited as approval and adoption of the Choctaw Nation of Oklahoma’s 2026 Opioid Settlement Funds Plan. See Exhibit A.

BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certifications, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
