**JAMES DRY INTRODUCED THE FOLLOWING COUNCIL BILL**

**A COUNCIL BILL**

**TO APPROVE** Funding for an Addition of a Dedicated Banquet Kitchen at Choctaw Landing in Hochatown to Support Special Events, Catering, and Banquet Operations.

**WHEREAS**, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma (the “Nation”), the Tribal Council of the Nation (the “Council”) shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

**WHEREAS**, the Nation currently owns and operates Choctaw Landing in Hochatown, Oklahoma (the “Facility”);

**WHEREAS**, the Nation seeks to add a dedicated banquet kitchen to the Facility to support special events, catering, and banquet operations, while enhancing operational capacity and creating a positive impact across the gaming and hospitality components of the Facility to promote the general welfare of its people and further the Nation’s self-determination and economic independence;

**WHEREAS**, the Council has determined that it is in the best interests of the Nation to approve funding in the amount up to Two Million Ninety-One Thousand Dollars (\$2,091,000) for the addition of a dedicated banquet kitchen at the Facility (the “Project Costs”);

**WHEREAS**, satisfactory due diligence, as reasonably determined by, and on terms reasonably satisfactory to, the Chief of the Nation, shall be completed prior to the construction of the dedicated banquet kitchen at the Facility; and

**WHEREAS**, the Council has determined that it is in the best interests of the Nation to fund the Project Costs from unrestricted funds.

**THEREFORE, BE IT ENACTED** by the Tribal Council that this Council Bill be cited as approval of the Project Costs.

**BE IT FURTHER ENACTED** by the Tribal Council that the addition of the dedicated banquet kitchen at the Facility shall be subject to the completion of satisfactory due diligence, as reasonably determined by and on terms reasonably acceptable to the Chief of the Nation.




